It's our honor to have our keynote speaker, Mr. Trevor Lui, Senior Consultant of World Bank Group, to share with us success stories of collaboration between the World Bank and its clients around the world—ministries and national agencies operating in various sectors. He will also touch upon his involvement with the World Bank, the operational background and real-world examples in Africa, India, Indonesia and Shanghai, China.



Mr. Trevor Lui, the keynote speaker of this event, is a strategic process and knowledge management (KM) consultant based in Hong Kong. He is one of the pioneers in knowledge management, customer relationship management / customer knowledge management, process innovation and change management. The most current client KM projects are from Estee Lauder APAC in Hong Kong and Asia Productivity Organization in Tokyo, Japan. Currently, Trevor is engaged with the World Bank's EFI Learning Innovation as one of the senior OKS consultants. He works closely with EFI Learning Innovation's Knowledge Hubs team in the World Bank in Washington, DC as well as local consultants and external partners across the globe to provide facilitation of workshops within existing and upcoming client engagements. This includes the facilitation of training workshops on the Knowledge Management Assessment, Visioning & Planning, Knowledge Sharing Organizational Leadership and Policy, and the Art of Knowledge Capturing for (i) the Shanghai National Accounting Institute (SNAI), the Asia-pacific Finance and Development Institute (AFDI) in Shanghai, China, (ii) the Federal Ministry of Agriculture and Rural Development (FMARD) in Abuja, Nigeria, (iii) the Lagos Metropolitan Area Transport Authority (LAMATA) in Lagos, Nigeria, (iv) the Ministry of Agriculture, Animals Industry and Fishery (MAAIF) in Uganda, and (v) National Aids Control Organization (NACO) in Delhi, India, client institutions that aim to strengthen their knowledge sharing capacity. In addition, Trevor was one of the founders of Knowledge Management Development Centre, a non-profit charitable organization with the objective to promote the awareness and advance the practice of Knowledge Management in Hong Kong.
